EPA - Environmental Education (EE) Grants | EPA

What this funds: Environmental education projects that "design, demonstrate, and/or disseminate environmental education practices, methods, or techniques." Must be a non-profit, school, or educational agency/entity to apply.

Sempra Liquefied Natural Gas (LNG) - Community | Sempra LNG

What this funds: Programs for the environment, education, and health and human services/safety in Sempra LNG communities.

SITKA Gear - SITKA® Ecosystem Grants (SEG) | SITKA

What this funds: Projects that "have the potential to advance and transform the confluence of the environmental + social landscape as it relates to wildlife, stewardship and conservation." Impact and success of the project must be qualitatively and quantitatively measurable.

TD - TD Charitable Foundation Grant | TD

What this funds: Non-profit institutions that support TD communities by addressing financial security, the environment, health and healthcare, or community connection (via events, arts and culture, etc.). They also sponsor local events, programs, projects, and activities in communities across America through the TD Bank Community Sponsorship Program.

California

WHALE TAIL® Competitive Grants Program - WHALE TAIL® Grants | California Coastal Commission

What this funds: Non-profit, school, district, or government entity initiatives in environmental education and/or stewardship that address audiences in California.

CalEPA EJ Small Grants Program - <u>Environmental Justice Small Grants and Funding</u> Opportunities | CalEPA

What this funds: Non-profit community organizations and federally-recognized Tribal governments working to address environmental justice issues. They focus on communities that are disproportionately affected by environmental pollution.

California Water Service Group (Cal Water) - Community Giving | Cal Water

What this funds: Programs that benefit communities in Cal Water service areas. In particular, they support initiatives for underserved communities that will have a measurable impact.

Sempra Energy - Corporate Giving Guidelines FAQ | Sempra

What this funds: Non-profit projects that focus on climate action, diversity and inclusion, or economic prosperity in Sempra Energy communities.

Applied Materials - Society | Applied Materials

What this funds: Initiatives in education, civic engagement, arts and culture, the environment, and women's and girls' empowerment. The Applied Materials Foundation also has an initiative called Generation Girl that works with US nonprofits to support girls' empowerment. What this funds: The creation of public gardens demonstrating water conservation and sustainable landscaping principles. Garden must be located in the EBMUD service area. Events and workshops hosted at such gardens may also be funded.

Valley Water (Santa Clara) - <u>Safe, Clean Water and Natural Flood Protection Grants &</u> Partnerships Program | Santa Clara Valley Water

What this funds: Schools, non-profits, and other government/community groups seeking to benefit Santa Clara County. Various grant opportunities may be available throughout the year.

SoCal

City of La Quinta - Community Services Grant Program | La Quinta

What this funds: Non-profit organizations that support the City of La Quinta, in particular those that support the business community. They offer grants for marketing/sponsorship as well as for economic development. Also available is the Community Development Block Grant (CDBG), a federally funded program for projects that help people with low to moderate incomes, clean/prevent slums, or aid community development in the wake of disasters or emergencies.

What this funds: Programs that benefit the communities Edison serves in southern California. There is a focus on education, the environment, public safety & emergency preparedness, and civic engagement. They also aim to help underserved groups and demographics.

What this funds: Non-profit organizations working to increase sustainability in the City of LA. Funded programs raise awareness of energy efficiency, water conservation, and sustainable practices through community outreach, transformational opportunities, and/or behavioral changes.

What this funds: Programs that improve education, health care, homelessness and social justice for Los Angeles residents. LADF focuses on pressing problems in underserved communities, including those induced by the COVID-19 pandemic.

What this funds: Washington State government parks and recreation agencies looking to create outdoor summer programming for underserved Washington youth/communities that have been impacted by COVID-19.
